- Along the fence heading south, plant material is green and healthy

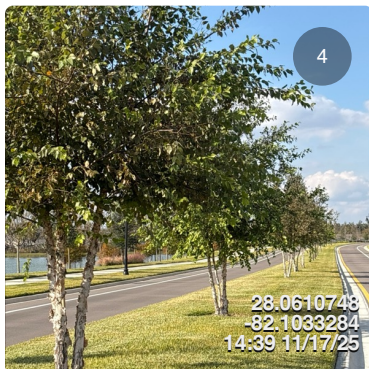
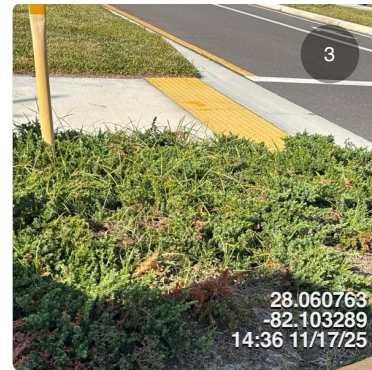
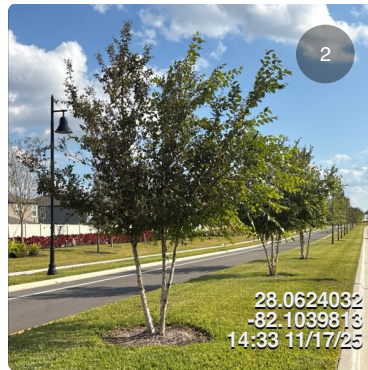
